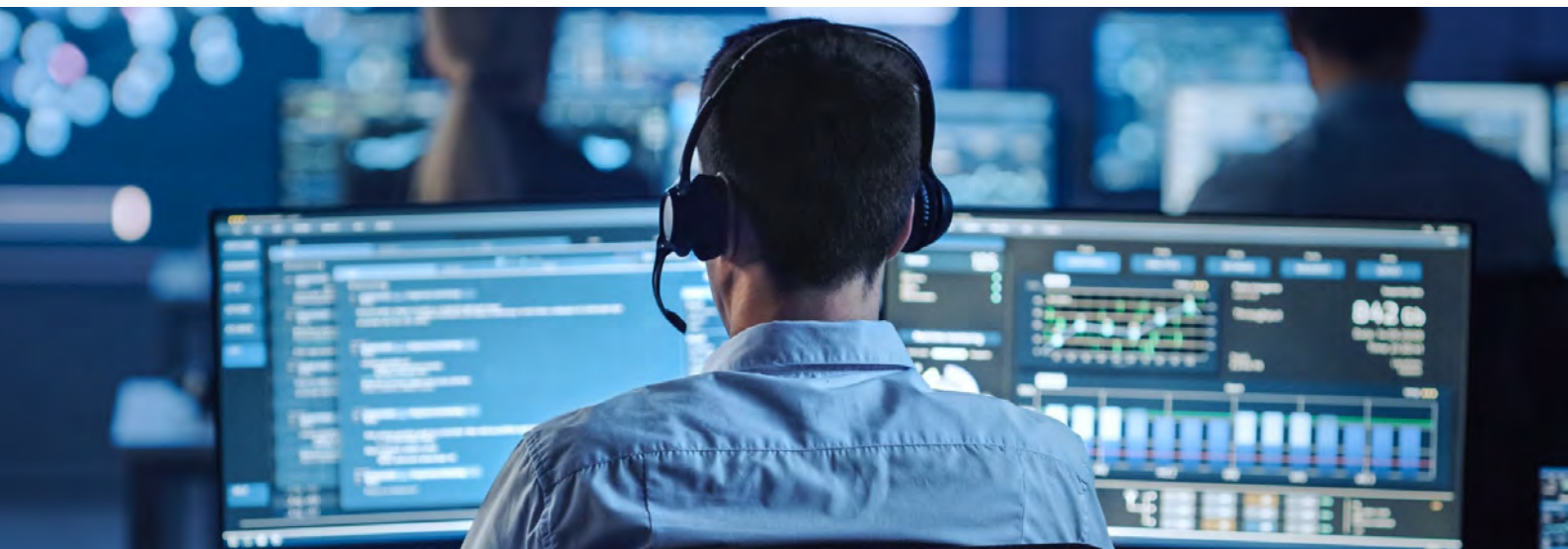
IT Manager as a Service (ITMaaS)
